- Have a picture ID

### REGISTRATION

You may register to vote through:

- Any Secretary of State branch office or on-line registration at <https://www.michigan.gov/sos>
- Your county, city, township, or village clerk's office

### IF YOU MOVE

- Within your city, township or village, notify your local clerk.
- Within Michigan during the 60 days before an election, you may vote one last time in that election at your former precinct or register in your new community.
