



**Isabella County Board of Commissioners**

Meetings: 12/2/2025 and 12/16/2025

- Approved an Ambulance Service Agreement with Mobile Medical Response (MMR), effective 2026 through 2030. MMR will be the exclusive provider of mobile basic and advanced life support ambulance services in the County and must adhere to the specific response times outlined in the agreement.
- Approved the Fiscal Year (FY) 2026 Community Corrections Grant Award of \$123,125 from the Michigan Department of Corrections. The funding supports comprehensive programs that address the State's priority of lowering the prison commitment rate through evidence-based rehabilitative services.
- Approved the FY 2026 Professional Services Agreement with the Tri-County Community Adjudication Program (TRI-CAP), not to exceed \$36,890. TRI-CAP provides a residential center curriculum as an alternative to jail for nonviolent offenders with substance use disorders.
- Approved a one-year renewal of the Lease Agreement with Broadway Land Management for 200 and 210 E. Broadway Street, the temporary location of the Prosecuting Attorney's Office. The rental cost is \$56,876 for the year.
- Adopted a resolution pledging the County's full faith and credit in the amount of \$1.28 million to finance improvements to the Struble Drain Drainage District.
- Approved contracts with University of Michigan Health-Sparrow for Medical Examiner services, covering the period from 2026 through 2029.

**Mt. Pleasant City Commission**

Meeting: 12/8/2025

- Approved a five-year agreement to continue providing fire protection to Union Township, a service the city has delivered since the 1960's. The city will be paid \$835,719 in 2026, with subsequent annual increases of 3.5%. The Township will supply a new fire truck in 2033, retaining full ownership.
- Approved updates to the Purchasing Manual to align with the latest Code of Federal Regulations for managing federal awards. Key changes include revised vendor selection procedures and the removal of the requirement to advertise the sale or disposal of equipment in the local newspaper.

**Mt. Pleasant Planning Commission**

Meeting: 12/4/2025

- Approved a site plan for a 64,062 sq. ft. addition to Wilson Steel Fab & Machine at 1219 N. Mission Street. The addition will be constructed in two phases.

**Mt. Pleasant Public Schools Board of Education**

Meeting: 12/15/2025

- Approved a new Advanced Placement course: Business with Personal Finance, which will launch in the 2026-27 school year. Along with the potential to earn college credit, the course offers students the opportunity to earn an employer-endorsed credential in the business field.
- Approved 4% wage increases for the Mt. Pleasant Education Association, the Mt. Pleasant Support Personnel Association, and the Mt. Pleasant Transportation Association.
